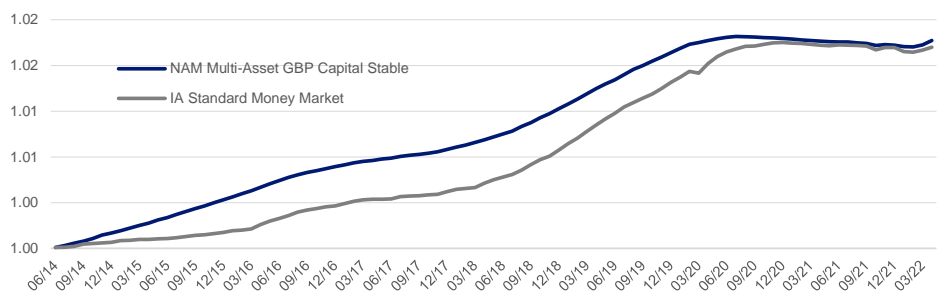
Current Asset Allocation

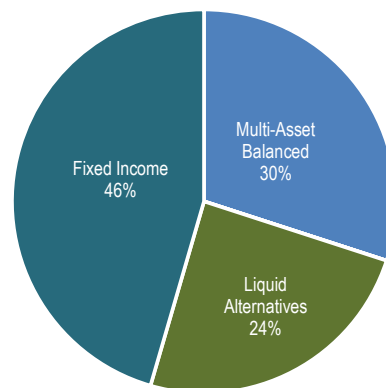

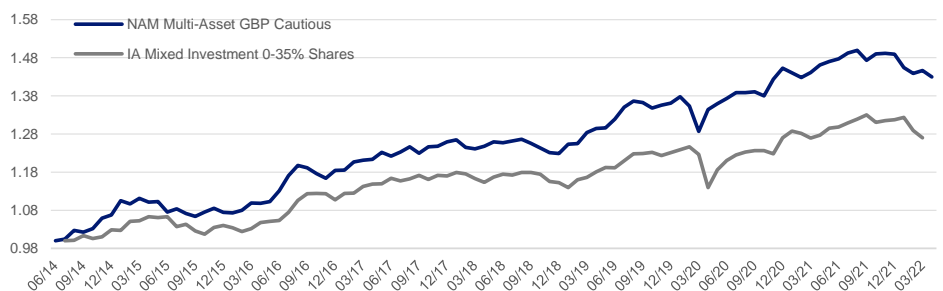
Current Asset Allocation

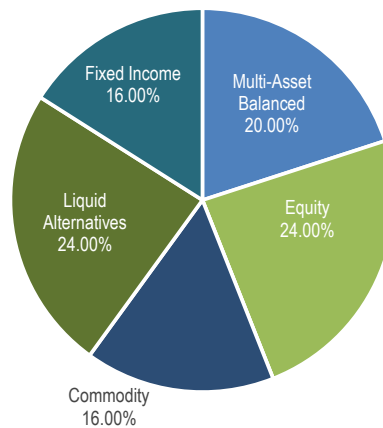

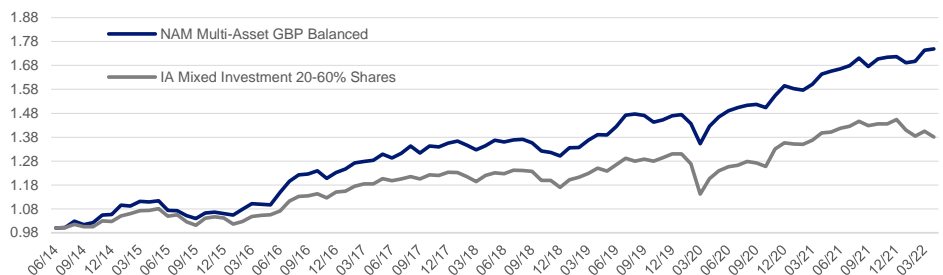
Current Asset Allocation

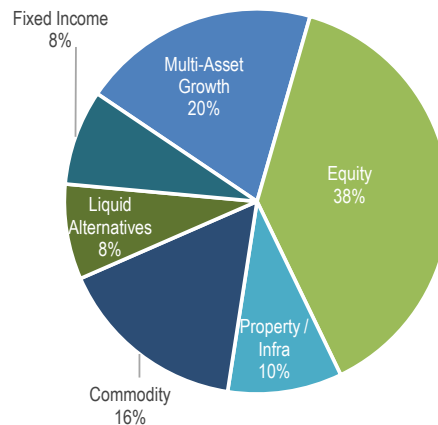

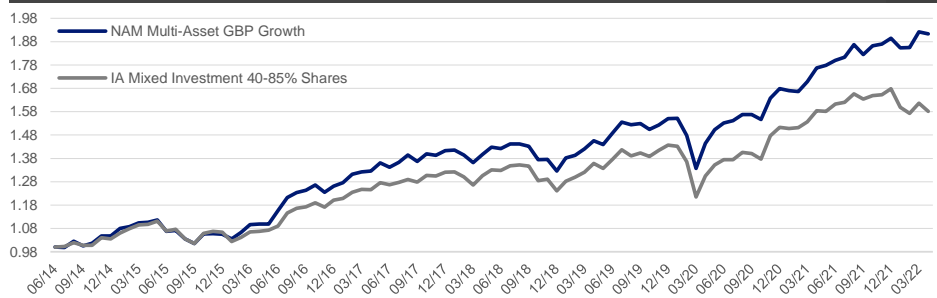
Current Asset Allocation
