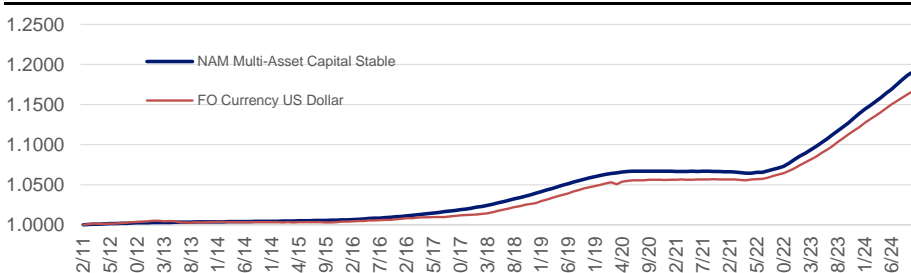

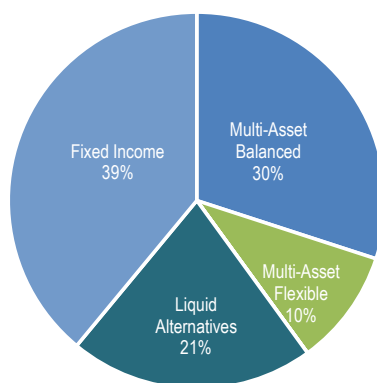

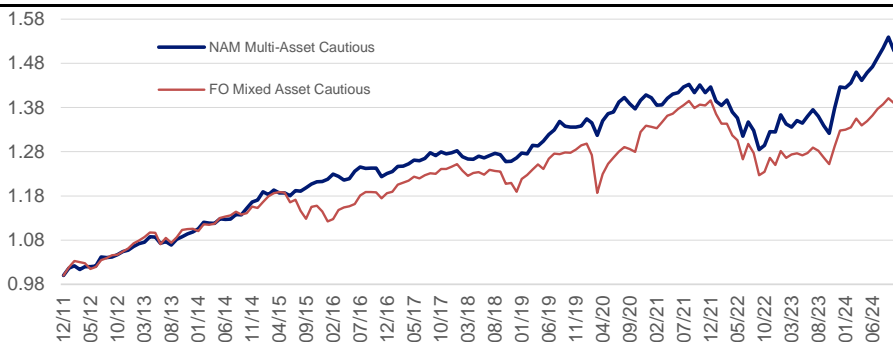
Strategic Asset Allocation

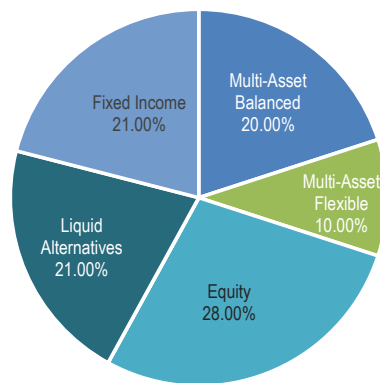

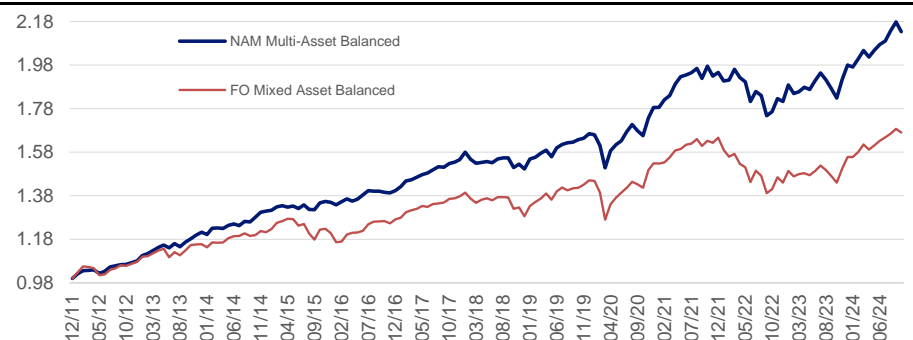
Strategic Asset Allocation

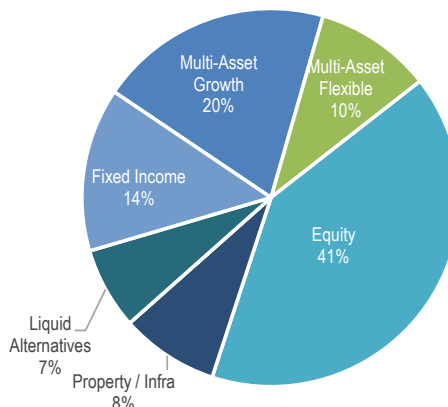

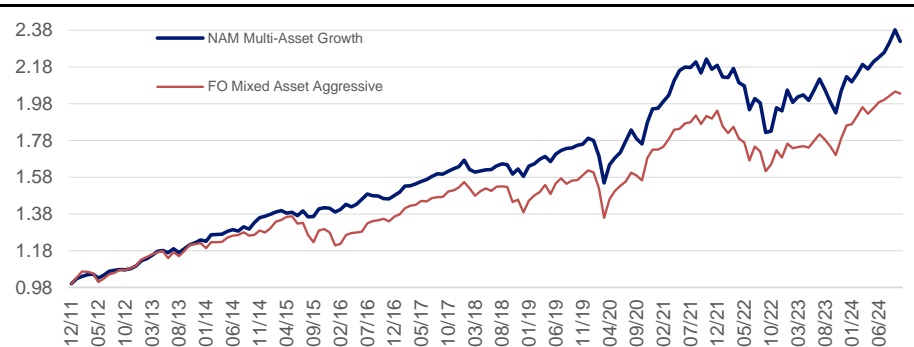
Strategic Asset Allocation
